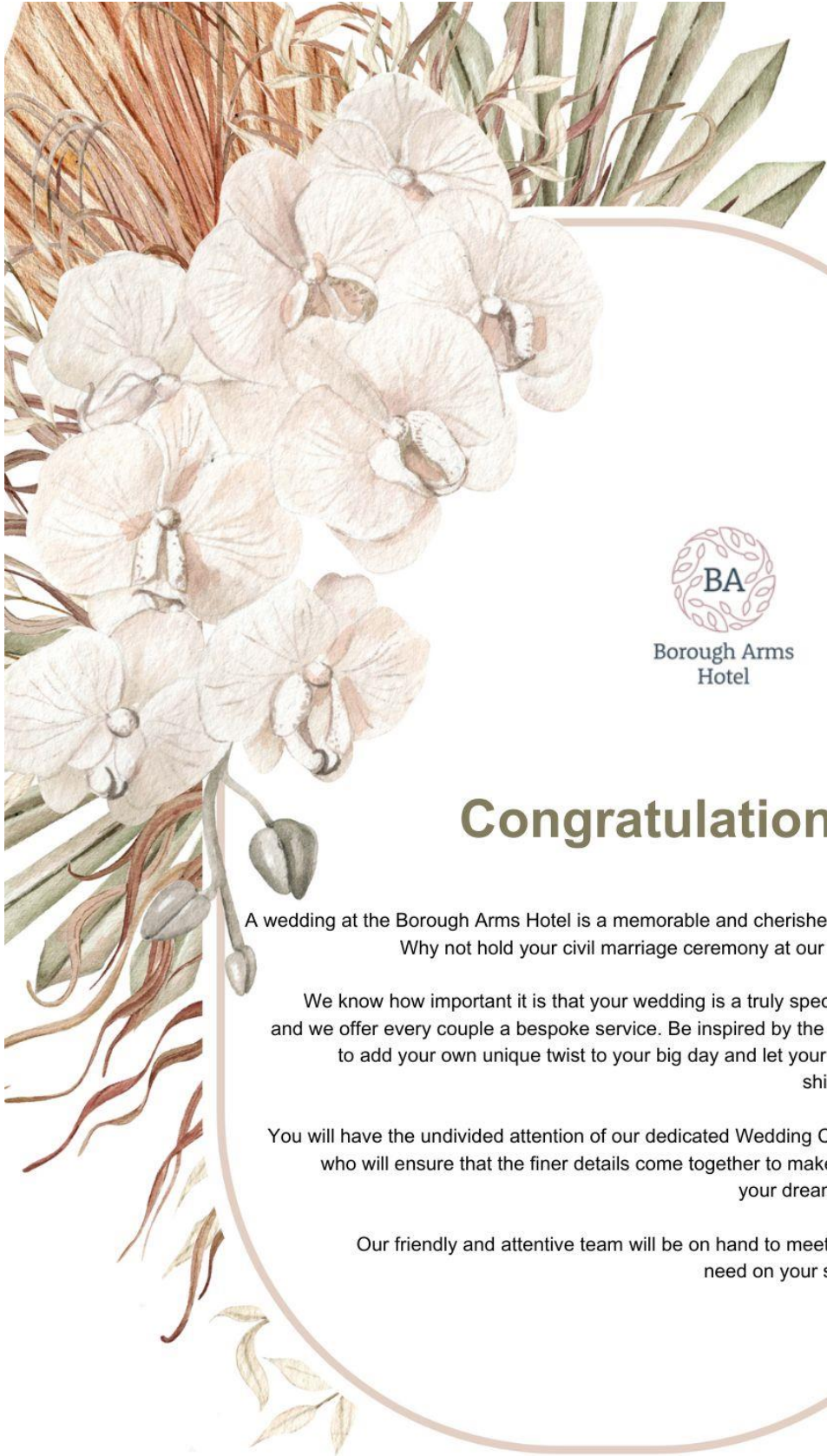

Wedding Terms & Conditions

Deposits and Payments

1. A non-refundable deposit of £750.00 is required within 14 days of a provisional booking.
2. Any balance must be settled no later than four weeks before your wedding date.
3. We require the precise numbers of guests attending no later than four weeks before your wedding date. (These numbers will be the minimum charge or 90% of the original number given, whichever is larger.)
4. Any food, drink, or services not in the contract must be paid for at the time of request.

Cancellations

1. Cancellation more than six months before the planned wedding do not incur any charge as long as we are successful in re-letting the room for a similar function. Otherwise, the charges below will apply which include an estimate of room hire, pre-booked food and beverages:

- Between 6 and 4 months prior to the event 25%
- Between 3 and 1 months prior to the event 75%
- Less than 1 month prior to the event 100%

2. Cancellation must be made in writing to the Borough Arms Hotel and will only be deemed to take effect from the date received. Postponement will be treated as a cancellation and the same Terms and Conditions apply.

3. We retain the right to cancel the booking without obligation in the unlikely event of fire, disputes with employees, alterations or decorations that are not ready on time or by the order of any Public Authority.

General

1. Any materials, mechanical or electrical equipment owned by you or your guests and used at our hotel, must be brought to the attention of the Hotel in writing. You will need our consent prior to the Wedding, and they must comply with all current relevant regulations. In the unlikely event of any issues, you will be liable for any damage or injury arising from the use of the equipment, unless it has been caused by the negligence of the Borough Arms Hotel's employees.

2. All property left on our premises is at the risk of all guests: we cannot be held responsible for any losses.

3. Incendiary or explosive devices or the use of candles in or around the Borough Arms Hotel is forbidden.

4. Prices are inclusive of VAT at 20% and due to market fluctuations may be subject to change without notice.
